Summary of meeting

1. Call to Order / Introductions

Chairman Mitchell calls the meeting to order at 10:04am.

2. Hearing of the Public

3. Annual Election of Chair and Vice-Chair

Secretary Aloiz called for nominations. A motion was made to nominate last year's chair and vice Chair—Mayor of Corry David Mitchell and City Traffic Engineer LeAnn Parmenter—by H. Stempka. No other nominations were made.

Motion to approve the nominations was made by J. Tushak and seconded by B. Kuhn. The chairs are re-elected unanimously.

4. 2021 Transportation Improvement Program (TIP)

b. Kevin McCullough discussed Covid relief funding and PennDOT pathways updates

c-e. Brandon Leach presented fiscal constraint charts, information item and CPDM item for +1 million change for the project at the intersection of SR99 and 6N in Edinboro Borough.

5. \$5 Local Use Fee new projects

J. Tushak, chairman of the local use fee subcommittee, presented the three bridges discussed at the subcommittee meeting held February 3rd 2021.

-Kahkwa Ave Bridge, in the City of Erie

A motion was made by M. Waldinger, seconded by B. Kuhn. Discussion included a description of the project including an access road and feasibility study are needed in the case of this bridge. The bridge was unanimously recommended to the Coordinating Committee for funding.

-Himrod Road Bridge, Waterford Township

A motion was made by J. Tushak and seconded by H. Stempka. The bridge was unanimously recommended to the Coordinating Committee for funding.

-Sherrod Hill Road Bridge, Elk Creek Township. A motion was made by B. Kuhn, seconded by J. Tushak. The bridge was unanimously recommended to the Coordinating Committee for funding.

M. Waldinger made a motion that the Kahkwa Ave Bridge funding could be voted on by e-ballot, with the stipulation that a description of the project phases be provided. This was seconded by B. Kuhn. Secretary Aloiz will confirm with the chairman of the coordinating committee that an e-ballot can be issued.

T. McClelland of PennDOT District 1-0 presented projects that will be let in 2021.

7. Active Erie Transportation Plan

Jeff Rigner of WRA presented the findings of a study conducted in the City of Erie

Secretary Aloiz mentioned that the 2021 Erie County At-Risk Bridge program will have a 60% match up to \$250,000.
