Clean and Green Checklist:

- New enrollment filing period March 1st thru June 1st of each year to apply for the following tax year.
- Separate application required for each parcel being enrolled.
- Filing fee (Separate filing fee for each application submitted).
- New enrollment \$50.00 application fee + \$18.50 recording fee.
- Re-enrollment \$18.50 recording fee only (filing deadline N/A).
- All owners' signatures required and the application must be notarized.
- Ownership must match in all 3 areas (This includes spelling, middle initials, hyphenated names etc.)
- Signature
- Notary Acknowledgement
- Corporation must provide Corporate Resolution/Authorization for designated signature.
- Make checks payable to: County of Erie
